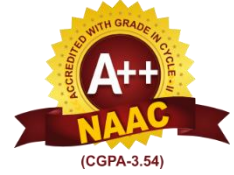

1	Termite Treatment: Termite treatment in the University based on IS:6313(Part-3)-1981 specification which consists of creating uninterrupted chemical barriers inside and all around the building. The treatment should be drill holes of 6mm as close as possible to the plinth, walls, junctions of the walls at an interval of 6 inches enough to reach the soil below 6 inches deep. Then chemical emulsion should be injected into these holes, which should be subsequently sealed using white cement match with floor colour all complete , The wall should be spray the chemical emulsion up to roof height wherever required complete.	124364	Sqmt
